FOOTNOTES

NOTE 1: To register for Section 1 of Independent Research I or Independent Research II, students must have a full-time faculty supervisor and obtain the approval of Associate Dean Chukwumerije. To register for Section 2 of Independent Research I, students must receive the written approval of Professor Duruigbo (emeka.duruigbo@tmslaw.tsu.edu).

NOTE 2: For Summer 2022, this course meets the writing requirement.

NOTE 3: You must have completed Independent Research I with a letter grade of B or better to enroll in Independent Research II.

NOTE 4: To enroll in this course, you must be a rising 3L student.
