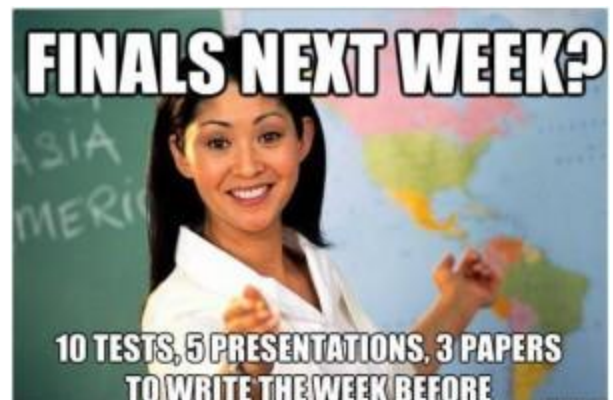
## PLAN, PRIORITIZE, AND DON'T PROCRASTINATE!!!

Finally, don't procrastinate. Law school can get overwhelming and it will become downright dreadful if you procrastinate.

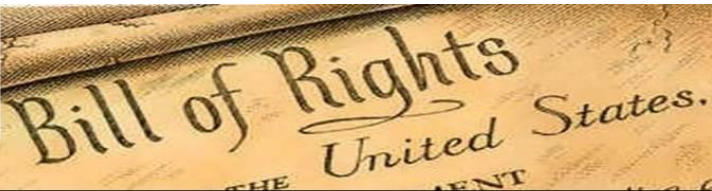


## PROTESTS, PEACE, AND POWER FORUM

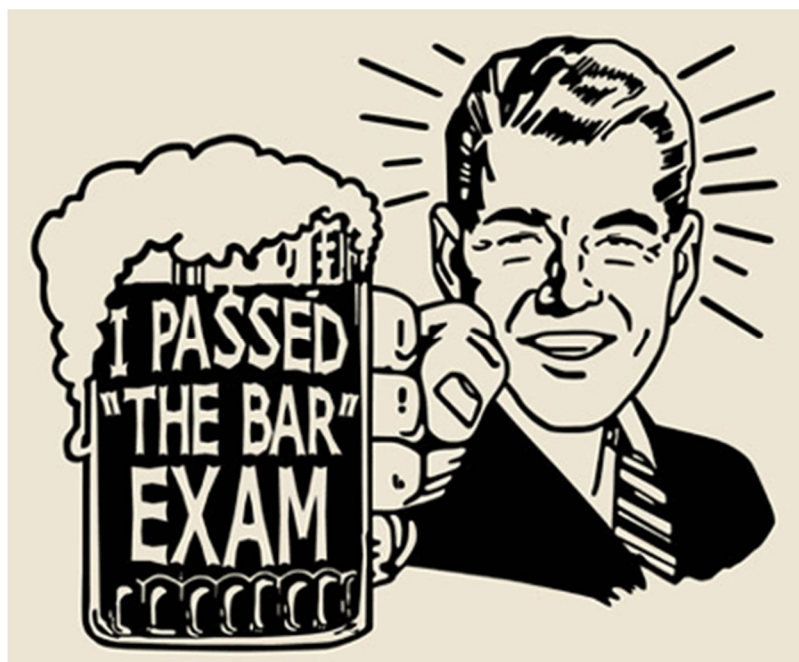
