Thurgood Marshall School of Law's Earl Carl Institute Receives Two Distinguished Honors in 2015-16



The NAACP Houston Branch held its annual Freedom Fund Awards Gala on October 30, 2015. The theme was "Pursuing Liberty in the Face of Injustice." It was the 92nd annual ceremony honoring and awarding individuals and organizations from the Houston area who have made significant contributions to the community.

This year the NAACP President's Award was given to the Anti-Defamation League and the Earl Carl Institute for Legal & Social Policy, Inc. ECI was specifically awarded based on its "...work as a think tank ... "that" aided the NAACP with research and statistical



gathering; helping locally, regionally and even nationally."

In her acceptance speech, Sarah Guidry, Executive Director of ECI, highlighted the disproportionate criminalization of our minority communities. She thanked the

NAACP for recognizing ECI and the urgent need to identify implementable solutions to the social issues that negatively impact our communities of color. Guidry also recognized members of the ECI staff who were all



in attendance.

ECI was also an honoree of Houston Lawyers Association ("HLA"), receiving its Mission Ally award at HLA's 2016 Annual Awards and Scholarship Gala. The gala was held on May 21, 2016.

Recipients of the award were individuals and organizations whose work embodies the HLA mission to address injustice and educate members and the community by

serving as a redress conduit, improving legal services and providing a voice for the community through advocacy, mentoring, professionalism and coalition building. Recipients of this award were said to be an example to members of the community as to what it means to either: (1) Address injustice by ensuring equal opportunity for black lawyers in employment and business opportunities; (2) Educate the community by supporting community programs that benefit the black community; (3) Serve as a redress conduit for the community; (4) Improve the quality and access to legal services; and (5) Provide a voice for the community through advocacy, mentoring, professionalism and coalition building.

FACULTY HIGHLIGHTS

Professor Emeka Duruigbo was a featured speaker at the 9th Sub-Saharan African Oil and Gas Conference held on April 27-28, 2016 at the Marriott Westchase, Houston, USA. Professor Duruigbo spoke on the opening day of the conference on the topic: "Positioning Sub-Saharan African Countries to Attract Investment in a Period of Low

Commodity Prices." In his presentation, Professor Duruigbo identified seven steps that oil and gas-rich African countries can take to be competitive in the increasingly tough energy investment climate, including feasible local content policies, formidable stabilization clauses, far-reaching political and legal reforms, functional basic infrastructure, firm tax incentives, friendly forex practices and fair treatment of host communities. Professor Duruigbo also emphasized the imperativeness of keeping a distance from inexpedient hyperbolic rhetoric and understanding that infusion of foreign capital into the local economy is often in the national interest.

In May 2016, a leading national newspaper in Nigeria, The Punch, sought Professor Duruigbo's views on the economic conditions that Nigeria is facing in light of sharp reduction in oil and gas production attributed to militancy in the oil-producing Niger Delta region. Professor Duruigbo noted that the economic implications of the supply disruption were serious and that some countries, notably Saudi Arabia, Iran, Venezuela and the United States, could take advantage of Nigeria's inability to meet its supply obligations to importing countries by taking some market share away from Nigeria. Professor L. Darnell Weeden's article entitled *Good Public Policy Occurs Under Plyler When In-State College Tuition Rates Are Awarded to Undocumented Bona Fide Resident Immigrants,* 25 <u>GEO. MASON U. CIV. RTS.</u> <u>L.J.</u> 191 (2015) was reported in an annotation in the Journal of Law and Education, 44 J.L. & Educ. 616 (2015), discuss-



ing recent issues involving universities and other institutions of higher learning. In its explanation of Professor Weeden's article, the Journal made the following observations: "In this article, the author argues that undocumented immigrant students with bona fide state residence status should be given access to in-state tuition rates in Texas. The author finds support for this argument in the Equal Protection Clause of the Fourteenth Amendment and by expanding the rationale of the 1982 Supreme Court case *Plyler v. Doe.* The author believes that by denying bona fide residences equal access to education, the states create an underclass of undereducated people. The author concludes by recommending that federal courts should require state governments to show at least legitimate government objectives before denying in-state tuition to undocumented immigrant students with bona fide state residence status."

Immigration Clinic get Special Immigrant Juvenile Petition Approved

Congratulations to the Thurgood Marshall School of Law's Immigration Clinic for procuring an approval of a Special Immigrant Juvenile Petition for their client, an El Salvadoran minor female who was the victim of multiple gang rapes and torture by an international human sex trafficking organization. Under the direction of Professor Maurice Hew, Jr, student attorneys, Anna Garza, Juan Carlos Cavillo, and Synthia Santiago made multiple appearances before the Board of Immigration Appeals and the local immigration court on a motion to reopen an in absentia order of removal and subsequent Master Calendar hearings; before the 313th Juvenile

Court for Harris County on an original petition for a declaratory judgment that the client was abused, abandoned, and neglected by her parents and that a return to El Salvador with her parents was not in the client's best interest; and before the Department of Homeland Security for the Special Immigrant Juvenile Petition. Kudos also to Marco Reyes, concerned citizen; Sandra Valerio Salas of Lone Star Legal Aid; attorney William Thursland, guardian ad litem; Cobie Devost, Health and Human Services; and former TMSLAW alumni, Patricia Ventura and Eunice Fernandez who collaborated with the legal clinic during various stages of this successful representation.
