

**Professor Stephanie Smith Ledesma's** second article, *The Vanishing of the African-American Family:* "Reasonable Efforts" and Its Connection To the Disproportionality of the Child Welfare System, was published this past fall in the Charleston Law Review,

Volume 9, Number 1. The article suggests that until indigent children in the child welfare system are protected from the "master narratives" of the child welfare system that plays out in hundreds of courtrooms across this nation on a daily basis through the inconsistent application of "reasonable efforts," the number of minority families dismantled by the child welfare



system will increase as will the "browning" of the child welfare system, as evidenced by the disproportionate number of African American children who are removed from their families and that subsequently age out of the child welfare system.






