NOTES

- FN 1 - Required second year course- must be taken this spring semester.

- FN 3 - May be taken in either the Second or Third year.
- FN 4 - Meets the writing requirement.
- FN 5 - For 3L students only
- FN 6 - Limited registration course offering. A student may not drop a seminar or clinic after January 14, 2015.
- FN 7 - Writing sample and resume required. The Criminal Externship requires a clean record!
- FN 8 - Minimum GPA requirement is 2.50 for state court and 3.0 for federal court.
- FN 9 - Registration by permission (See Dean Mouton)
- FN 10 - Prerequisite-Federal Income Tax.
- FN 11 - Cannot take more than one in same semester.
- FN 12 - Must be taken in conjunction with (at the same time as) Criminal , Civil , or Administrative Trial Practice.
