
# COVID-19 RESPONSE & RESOURCE GUIDE

If you are concerned about being able to stay in your home or believe that you are at risk of eviction or foreclosure due to economic issues caused by loss of employment or other financial implications resulting from the stay at home orders, please contact our office for assistance with eviction defense, landlord/tenant issues and foreclosure defense. The Opal Mitchell Lee Property Preservation Project will advocate for you so that you and your family

can continue to be safe in your home. We can also assist with estate planning so that you can be certain that your house is in order during these uncertain times.

# **TEXAS EVICTIONS**

In response to COVID-19 Emergency Order 9 was issued on April 6, 2020, the Supreme Court prohibiting a trial, hearing, or other proceeding in an eviction to recover possession

of residential property under Chapter 24 of the Property Code and Rule 510 of the Texas Rules of Civil Procedure until after April 30, 2020.

# FORECLOSURES

#### Federal Government Mandates

A new federal law, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, puts in place two protections for homeowners with <u>federally backed</u> mortgages:

- A foreclosure moratorium
- A right to forbearance for homeowners who are experiencing a financial hardship due to the COVID-19 emergency.

If you don't have a federally backed mortgage, you still may have relief options through your mortgage servicer or from your state.

#### Harris County Mandates

Harris County has passed temporary rules that may help protect you against foreclosures or from having your foreclosed property sold at auction.

The Harris County Commissioners Court cancelled the April 7, 2020 tax foreclosure sale. No foreclosed homes will be sold at auction in April. To view the hearing: <u>https://harriscountytx.new.swagit.com/videos/44449</u>

# **PROPERTY TAXES**

Harris County Tax Assessor-Collector & Voter Registrar Ann Harris Bennett announced that the Tax Office is providing a three-month extension of all 12-month delinquent property tax payment plans as a result of the COVID-19 pandemic. Property owners with 12-month installment payment plans will not have to make payments for March, April, or May 2020.

JJP understands how having a criminal record can negatively impact a person's life and how important it is to be able to have the record cleared. We offer pro bono criminal record expunction and non-disclosure services for people who have faced a criminal charge between the ages of 17-25 years old through our Clean Slate Cooperative.
