COURSE DESCRIPTION AND GOALS:

Trial Simulation is a four-credit hour course, (Spring) which is designed to teach second year students persuasive trial advocacy skills, motion practice, introduction of evidence and organizational skills.

COURSE OBJECTIVE:

To introduce and instruct second-year law students on the trial process in the context of drafting motions in preparation for trial. Students will be introduced to trial preparation and trial presentation. Specifically, students will be introduced to the entire trial process, in an effort to prepare them to engage in vigorous advocacy for their clients. Students will be instructed on the substantive law, rules of evidence, rules of procedure, and legal ethics.

To effectively present the skills of trial practice to second year students in both general concepts and particular categories of evidence.

To provide the students with a carefully structured history and common principal of practical trial skills and evidence.

To enable the law student to master the construction of a trial while creating familiarity and confidence in the trial process.
