CONCEALED HANDGUN POLICY

As you know, the State of Texas has recently passed legislation permitting you to carry a *concealed* firearm on campus if you have a concealed license permit recognized by the State of Texas, subject to the rules and regulations of Texas Southern University's ("TSU's) Campus Carry Policy. Under TSU's Campus Carry Policy, I have the right to designate my office as a gun-free zone. I have elected to make my office a firearm-free space. Pursuant to Section 30.06, Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a concealed handgun. COURSE DESCRIPTION & OBJECTIVE

DESCRIPTION:

Domestic relations, also referred to as "family law", is an area of civil law, (civil law covers all areas of law that are not military and are not criminal; hence, family, tort, contracts, sports and entertainment, etc.), that impacts most people at some point in their lives, either directly or indirectly. This course provides a broad introduction to the matters involved in the area of Domestic Relations, an area of law consistently tested on the Texas bar exam, and a potential subject to be tested for the Uniform Bar Exam, (Texas, February 2021).

During this course, we will study how federal and state governments both protect and confine family structures and individuals' rights and responsibilities to their family unit; how marriages are entered and dissolved; care and custody of children in the family unit; and the financial consequences to spouses and parents when families restructure.

In addition to learning fundamentals of family law doctrine and how this doctrine responds to and shapes social norms, this course will also require students to think critically about the roles legal professionals—lawyers and judges—play in shaping families' lives.

OBJECTIVE:

The objective of the class is to provide a platform for the critical analysis of and open and challenging discussions of family law matters. While community property laws will be discussed, the focus of the course is not an in-depth exploration of community property. This course is appropriate both for students who will or have taken a marital property course, and for those who will or have not.

The course begins with an overview of the fundamental right to marry, and proceeds into a review and discussion of the fundamental right to privacy. Other aspects of family law are studied also, including common law marriage, premarital agreements, annulments, adoptions, paternity, termination of parental rights, support, modification orders, enforcement orders, family violence and orders for family protection. Students will learn common terminology in family law and some of the procedural concerns that are often at issue.
