- (4) Excerpt from the <u>Legal Writing Handbook: Analysis, Research, and Writing</u> by Laurel Oates and Anne Enquist. This excerpt is posted on my TWEN course page. Please read pp. 27-30 of this excerpt.
- (5) "The Critical Legal Thinker's Case Briefing Model" on pp. 7-9 in the Reader. This is the case briefing model that you may have used during Orientation.
- (6) "How to Brief a Case" on pp. 10-14 in the Reader. This is another format for briefing a case.
- (7) <u>A Lawyer Writes</u> by Coughlin, Malmud & Patrick: pp. 34-35 ("Learning to Read for a Purpose") and pp. 43-56.
- (8) <u>Legal Analysis: 100 Exercises for Mastery</u> by Hill & Vukadin: pp. xi-xii, xvii-xviii ("For the Law Student"), and xix-xxi.
- (9) In <u>Legal Analysis: 100 Exercises for Mastery</u>, complete Orientation to Critical Thinking Exercise #1 on p. 3. Your written answer does not need to comply with the format requirements outlined in the Course Guidelines. Bring a

copy of your written response to class. Keep a copy for yourself. You will turn in your assignment at the end of class.

You can purchase the Reader from Texas Southern University's Copy Center in the Student Life Center (second floor). The Reader should be available for purchase by Monday, August 12. I also will post the reading materials assigned for the first two days of class on my TWEN course page. You must purchase your own copy of the Reader. Unless otherwise instructed, you should bring the Reader to every class.

For your <u>second day of class</u>, please do the following:

- (1) Read and brief the case of <u>Eilers v. Coy</u>. The <u>Eilers</u> case is in the Reader on pp. 15-17. You may use the format suggested in the Reader on pp. 7-9 ("The Critical Legal Thinker's Case Briefing Model") or the format discussed on pp. 10-14 ("How to Brief a Case"). The decision is up to you. And feel free to prepare two case briefs, one for each format. There are many ways to brief a case and you will find your own style over the next few months.
- (2) Complete the Discussion Questions for the <u>Eilers</u> case. These discussion questions will be posted on my TWEN course page by Friday, August 16 (if not sooner).

You should bring two (2) copies of your brief and your answers to the discussion questions to class, as we will be discussing the case in depth during the first week. You will turn in one copy of your brief and answers at the start of class. The brief and your answers do not need to comply with the format requirements outlined in the Course Guidelines but your brief should follow one of the formats provided in the Reader.

(3) In <u>Legal Analysis: 100 Exercises for Mastery</u>, complete Orientation to Critical Thinking Exercise #2 on p. 4. Your written answer does not need to comply with the format requirements outlined in the Course Guidelines. Bring a copy of your written response to class. Keep a copy for yourself. You will turn in your assignment at the start of class.
