FROM THE OFFICE OF THE DEAN:

Season's Greetings TMSL Family:

The holiday season is upon us! At this time of the year, we will join family and friends to give thanks and share our appreciation for the multitude of blessings we've been fortunate to receive throughout the year. As we embrace the holiday season, I'd like to take a moment to express my sincere appreciation to each of you. The Law School is indeed most fortunate to count you among its dedicated and committed supporters and I can't thank you enough for your past commitment and generosity. It is because of your efforts and continual support of the



Law School, we advance our mission of providing excellence in education for our students.

The year 2014 earmarked impressive growth and success at the Law School. We started the year with our admission into the esteemed membership of the Association of American Law Schools (AALS) in January, receiving a national vote of confidence for our direction, faculty, academic and accountability programs and our ability to engage with students to produce competent and capable lawyers. Our membership not only signifies that the Law School reflects the Association's core values and has met the rigorous requirements specified in the AALS Bylaws and Executive Committee Regulations, but enhances our faculty's opportunity to play national leadership roles in the academy, while qualifying our Law School to provide further recognition for our students by applying for membership in the Order of the Coif. For this milestone achievement, the Law School was presented with Certificates of Special Congressional Recognition from Congresswoman Sheila Jackson Lee and Congressman Al Green on behalf of the 18th Congressional District of Texas and the 9th Congressional District of Texas, respectively, at a Celebratory Luncheon at the Four Seasons Hotel in March 2014.

Also, in March 2014, the entire administrative team and faculty participated in an intensive, two-day Staff and Faculty Retreat, where everyone worked diligently and collectively to implement the Law School's revamp of its Strategic Plan and initiated preparation of a Self-Study, ultimately involving an enterprise of key stakeholders including faculty, staff, students, alumni and members of our legal community. This labor-intensive process was strategically implemented for the much-anticipated site visit by the American Bar Association in November 2014, as required by the ABA Standards for Approval of Law Schools and organized by the ABA Section of Legal Education and Admissions to the Bar.

Our Strategic Plan included a vision statement, overarching goals, and measures of accountability, whereas our Self Study stated the goals that the Law School has set for itself, identified and analyzed the school's strengths and weaknesses in light of those goals, and related the present and prospective resources to the stated objectives. We, along with TSU Administration welcomed the ABA Site Team on Sunday, November 2nd, led by ABA Site Team Chair Adrian Wing. For a duration of four days, we made ourselves available and accessible for questions, dialogue and review of the Law School's data. Although we await the final reporting from the site visit, we remain not only honored by the resounding praise and commendations received from ABA site members during their visit to our campus, but confident that from the ABA Site Visit results, the Law School will rise to the occasion to sustain and enhance its upward arc in advancing our Law School's mission.

We are very proud of our diverse TMSL faculty. Our faculty has demonstrated their commitment to scholarship and teaching efforts this year. Several members of the faculty published books this year and/or published articles in leading law reviews, covering a wide range of topics. In addition, our faculty has demonstrated a willingness to take controversial positions and speak on topics (locally and nationally) that impact our society. This year for the first time, our faculty has adopted institutional learning outcomes that will guide our teachings as we move forward.

We have had members of our TMSL family retire or move on to other endeavors, but we have been fortunate to have new members of the TMSL faculty and staff join us with solidified professional skill sets necessary to promote growth and achievement in their respective areas of the law school. These new additions are: Assistant Professor Peter Marchetti; Susan Bynam, Assistant Dean for Institutional Advancement; Marsha Griggs, Assistant Dean of Academic Support & Bar Readiness; Cynthia Estrada, Office Administrator; Lewis Little, Network Administrator; Daniel Brackmann, Electronic Resources Librarian; Karim Rand Alridge, Technical Services Director; and Senior Administrative Assistants-Legal - Kathy McKenzie, Toyann Timmons and Carol Stewart.

And, we couldn't be more proud of our students! Our TMSL Mock Trial and Moot Court Teams continue to emerge victorious and leave marks of success in competitions around the coun-The TMSL Mock Trial Team reigned as champion of the National Trial Competition (NTC) Regional, the 2014 Rocky Mountain Mock Trial Program Competition sponsored by NBLSA and took 2nd Place at the 2014 ABA Labor and Employment Law Trial Advocacy Regional Competi-Additionally, the Experiential Learning, TMSL Moot Court Program received national recognition for advancing to semi-final rounds of the ABA Forum for Communications Law First Amendment and Media Law Diversity Moot Court Competition.

And, as we neared the end of a productive semester at the Law School, we received yet more great news. In November 2014, the National Jurist Magazine ranked the Law School #1 in the nation as "Best Law School for Diversity" out of approximately 200 ABA accredited law schools in the country.



FACULTY HIGHLIGHTS



On November 19, 2014, **Professor SpearIt** gave a talk at TMSL sponsored by the Hispanic Law Student Association entitled *Convictions, Corrections & Communities: How Imprisonment Underdevelops Latino Communities.* On November 21, 2014, **Professor SpearIt** spoke at the 2014 Lassiter Conference at

the University of Kentucky College of Law about Structural Harm in the Age of Mass Incarceration. In addition, Professor SpearIt was featured in the American Society of Criminology Critical Criminology Fall 2014 newsletter as a result of his talk entitled Sonic Jihad: Muslim Hip Hop in the Age of Mass Incarceration at the International Crime, Media and Popular Culture Studies Conference. Professor SpearIt was also featured in the University of Denver Sturm College of Law blog in connection with his work in SALT.

In October 16-17, 2014, **Professor Fernando Colon-Navarro** served as a Special Lecturer at the *São Paulo Law School of the Getulio Vargas Foundation* in Sao Paulo, Brazil. While there, Professor Fernando Colon-Navarro gave a talk on the use of technology in the law school classroom, lectured on the fundamentals of U.S. immi-

L. **Professor** Darnell Weeden accepted an offer of publication from the Whittier Law Review to publish his article entitled "Leadership Matters: Sav-Judge Scheindlin's NYPDRacial Profiling Remedy in Floyd V. City of New York." Weeden's article addresses the issue of whether the Fourth Amendment and Fourteenth



Amendment prohibit the police from engaging in a racially biased stop and frisk policy, with race being either the predominant or only factor utilized. Weeden supports the contention that racial bias has a chilling effect on the rights of minorities in the criminal justice system. The Black experience of many African Americans and the Brown experience of many Latino Americans support the conclusion that racial profiling occurs every time a police officer suspects criminal activity based predominantly on any widespread negative racial stereotype. Weeden asserts there are a number of good reasons for rejecting the police practice of racial profiling in stop-and-frisk cases and promoting the position that the practice is a violation of both the Fourth Amendment right against unreasonable searches and seizures, and the Equal Protection Clause of the Fourteenth Amendment. In the article Weeden argues that laws or policies permitting racial profiling should be considered unconstitutional as well as poor public policy.

Professor April Walker was recently invited to interview with Keneilwe Sebola, producer for Power FM Radio in Johannesburg, South Africa, to discuss racial profiling in America and how incidents such as the Ferguson-Michael Brown story and racial profiling continue to impact communities and policy globally. Power FM Radio in Johannesburg (aka Power 98.7FM) is a South African commercial, talk radio station based in the Gauteng province.

Distinguished Professor James M. Douglas was elected President of the NAACP-Houston Branch in November. His term begins January 2015.

Dean Griggs in the Hall of Fame



Our very own TMSL Assistant Dean of Academic Support and Bar Readiness Marsha Griggs was recently inducted into the Texas Verdicts Hall of Fame. She was inducted for her outstanding verdict in City of Dallas v. TCI West End Inc., a case that she successful-

ly tried to a jury in 2010. After a 10 day trial, a Dallas County jury awarded \$2,250,619.50 to Plaintiffs the City of Dallas and the Texas Historical Commission. The award was one of the largest fraud verdicts in the state

The case was brought against a single-asset subsidiary holding company established by a real estate investment firm, that demolished a historic building, which is both a city historic district and a district listed in the National Register of Historic Places. The 30,000 square foot brick building was built around 1925 and was a key part of Dallas' emergence as a rail center. Facts presented at trial showed that Defendant TCI sought and obtained a demolition permit from the City, but deceptively stated in the permit application that the company's intentions were to demolish a "500 square-foot guard shack" on the premises, but failed to disclose that that its intentions to raze a historic building that had sat on the lot for over 80 years. Griggs was the lead attorney in the case, representing the City of Dallas. At the time of trial, the case had been pending for four years. Former Dallas Mayor Tom Leppert commented that the verdict was significant victory that "reaffirm[ed] the importance of the City's historic structures and the established processes that must be respected -- the kind that sends a message that you don't violate the city's historic preservation ordinance and get away with it."

ECI Seeks New Associate Director, Center for Government Law

Under the direction of the Law School's Dean, Earl Carl Institute Executive Director, faculty and administration the Associate Director of the ECI Center for Government Law (CGL) will supervise the center's day-to-day operations and staff members. The CGL Associate Director will develop programs to advance the Center's mission and the mission of ECI. The Associate Director position will assist students as well as other ECI staff with research and writing projects. The position serves as the primary source for the research and development of government law and public policy articles, studies, papers, and reports in related areas. The candidate selected will act as liaison for various committees and executives in other State government organizations.

<u>Position Requirements:</u> Must have substantial experience in the area of governmental law and public policy. Requires more than seven years of related experience. Requires a Juris Doctorate Degree from an ABA accredited law school.

The Earl Carl Institute's Center for Government Law was established to provide integrated academic and practical skills training in government administration and regulation to law students. Preparing students for the practice of law in the public sector is a primary goal of the Center. The Center works with numerous governmental organizations on the local, state and federal level. The Center also serves as a bridge between government and academia by providing practical experience to students who assist government leaders in advancing research in a multitude of law and public policy arenas.

In addition, the Center is responsible for a report on each Legislative session on the impact of new legislation on TSU and the urban community. It is the goal of the center to become an authority and resource on urban issues for legislators and other policy organizations.




