The Association of American Law Schools (AALS) Site Visit



In Thurgood Marshall School of Law, Texas Southern University's effort to continue to strive for excellence, the law school applied for membership to The Association of American Law Schools (AALS), a non-profit educational association of approximately 180 law schools that represents over 10,000 faculty members in the United States. On March 24-27th 2013 a site team appointed by the AALS visited the law school to fact find and assist the organization in determining if the law school meets its current membership standards. The site team was made up of five distinguished legal academics with extensive experience serving as inspectors of law schools. The persons who served on the site team were:

- 1. Dean Rifkin, College of Law Distinguished Professor, University of Tennessee College of Law, Chair.
- 2. **Regina Burch**, Associate Dean for Graduate Programs and Professor of Law, Capital University Law School.
- 3. Okianer Christian Dark, Interim Dean and Professor of Law, Howard University School of Law.
- 4. **James B. Leonard**, Associate Dean for Legal Information Services and James M. Kidd, Sr. Professor of Law, University of Alabama School of Law.
- 5. Richard J. Morgan, former Dean of the Wyoming, Arizona State, and UNLV Schools of Law.

Team members evaluated the quality of teaching by visiting over twenty classes. The team reviewed the scholarship of the faculty, and met with the faculty, students, and staff of the law school. The team also met with President Rudley and Provost Ohia, and with members of the law school's Blue Ribbon Committee consisting of alumni and friends of the university and law school (pictured & see page 2).

All participants appeared to warmly welcome, cooperate with, and engage the team in a manner that should facilitate the team's ability to effectively complete its fact finding assignment. The team will issue a preliminary report in late June or early July. The law school and university will be given the opportunity to review that report and provide evidence to correct any errors or omissions. The final report will then go the AALS Membership Review Committee who will invite the chair of the site team, Dean Holley, and President Rudley to appear before it in late September. The Committee's decision will be forwarded to the Executive Committee of the AALS for review. If the law school receives a favorable membership recommendation, it would be admitted to membership at the national AALS meeting in January, 2014.

Victor Vital Leads Trial Team to Secure \$6.9 Million Jury Verdict




DALLAS, TX (03/06/2013) – Victor Vital, a shareholder in the Dallas office of the international law firm Greenberg Traurig, LLP, recently won a \$6.9 million jury verdict, including \$1.75 million in punitive damages. Vital and his team tried the case for Horizon Health Corporation, a wholly-owned subsidiary of firm client Universal Health Services, against Acadia Healthcare Company and other defendants on claims of breach of non-competition and non-solicitation covenants, theft of trade secrets, breach of fiduciary duty, tortious interference and fraud. The trial team also secured a \$41,000 discovery sanction and a spoliation/adverse inference instruction against one of the defendants.

"We are thrilled to have helped our client achieve this trial victory," Vital noted. "We believe in protecting and pursuing the rights of our clients in trial matters in courts throughout Texas and across the country."


FACULTY HIGHLIGHTS


