Thurgood Marshall School of Law Recognized for Being the Most Diverse Law School in the Nation

Texas Southern University-Thurgood Marshall School of Law (TMSL) received the top honor by *The National Jurist* as the Most Diverse Law School in the Nation. Because of the historically African-American law school's history of cultivating diversity, this news is not a surprise to many. When the study was done two years ago, the school finished fourth among other top schools, such as The University of the District of Columbia (UDC) School of Law; this year, however, UDC School of Law came in second instead of first.

The National Jurist derived its rankings by calculating the percentage of students and faculty by ethnicity. Each school was given a score from 1-10 for all ethnicities, except for American Indians, for which schools received scores from 1-5. The calculations revealed Texas Southern University with the highest score of 7.1 followed by the UDC School of Law with a score of 6.52.

Dean Holley was interviewed by the magazine, and most of his comments in the magazine are reported below.

"Holley of Texas Southern is used to his school receiving honors fro diversity. It doesn't get old either, he said.

His school dates back to the late 1940s when a black postal worker who wanted to enter University of Texas School of Law sued the state of Texas. To thwart the move, the state created a "separate but equal" black-only school for a number of professions, including law. Later, a young African-American lawyer, Thurgood Marshall, would successfully argue before the U.S. Supreme Court that the new school was separate, but certainly not equal. It led to the University of Texas' ultimate integration.

As the years passed, Texas Southern University became a leader in the training of African-American attorneys. And it still is. From a five-year period ending in 2012, the school produced 43 percent of the newly licensed African-American attorneys in the state of Texas. The school has only 5 percent of the state's total law school enrollment.

But it also has evolved to become an attractive school for Latino students, given the growth of the Hispanic population in the state. More than 30 percent of the school is Hispanic. Holley also notes that white students find it attractive, given how society is becoming more diverse. During the past several years, between 15 percent to 20 percent of the student body has been white.

Holley shared quotes by students, noting the importance of diversity in making their decision to come to the school.

'Growing up as a military brat and being in the military myself, I was always used to being around a diverse group of people,' wrote Ricardo Ramos, Jr., Class of 2014. 'You won't find diversity at any other law school the way you will at TMSL. I felt at home. It was where I needed to be.'

Holley notes there are 200 American Bar Association-accredited law schools and each has 'a different narrative' when it comes to how theses minority students are being absorbed. Some schools are not seeing gains, while others are improving significantly.

Diversity only goes so far in attracting students, he said. His students want an education that makes them practice-ready and competitive with the best, he said. They may feel more welcome at the school, and their views may be more readily heard, but that's not the end-all, be-all. They also want clinics and externships and other practical training."

The National Jurist's analysis of the drop of law school enrollment shows interesting developments: The number of law students has dropped 15 percent from 2011 to 2013, but the number of minority law students has dropped only 4.2 percent--showing an unmatched decline between races. Reginald Daniel Wilson Jr. is a third year law student at Texas Southern University – Thurgood Marshall School of Law and anticipates graduating in May 2015. Reginald has recently accepted an offer of employment from Norton Rose Fulbright in its Public Finance section. He is currently ranked in the top five percent of

the 2015 class.

Reginald was born in Abbeville, LA, and graduated high school from Plano East Senior High in Plano, TX. He received a full athletic and academic scholarship to attend and play football for Texas Southern University. There he was elected as one of the Co-Captains for the Fighting Tigers Football Team by his coaches and teammates. In addition, he served as the Vice President of the Fredrick Douglass Honors Program in undergraduate school. In the spring 2008, he was inducted into Alpha Phi Alpha Fraternity Incorporated, serving as the sergeant-at-arms. Reginald went on to receive his B.B.A. in Marketing from Texas Southern University.
