

Associate Dean L. Darnell Weeden recently accepted an offer from the Appalachian Journal of Law to publish his article entitled “A Functional Free Exercise Clause Analysis Requires a State to Prove a Compelling Interest before Interfering with an Individual’s Faith Based Same Sex Marriage Participation Objections.” The primary issue considered by Weeden is whether the First Amendment should require a state to demonstrate a compelling state interest before it is allowed to substantially interfere with an individual’s free exercise marriage participation rights? The Appalachian Journal of Law is published by The Appalachian School of Law which is located in Grundy, Virginia.



Professor Marcia Johnson has accepted the invitation from Texas Southern University President Austin Lane to serve as the leader in a plan that helps to achieve the university’s work in an urban community. The plan includes the Urban Research and Resource Center (URRC) which was established in January 2017 and received notice of partial funding in October 2017. According to Johnson, Director of URRC, the URRC has five focal points: (1) Public Education reform, (2) criminal justice reform, (3) the history of African Americans in Houston, (4) Community and Economic Development and (5) Community Resources. In Public Education, the URRC has launched a collaboration with various TSU and outside education experts to develop an academic excellence model for urban education. Its first focus is K-12. The URRC has declared 2019 as the Year of Criminal Justice Reform in an effort to confront and help solve many areas of criminal system injustice particularly as it relates to the urban community. Through work with various partners, Johnson has led efforts for the URRC to garner commitments from Houston-area community organizations, educational entities, faith-based institutions and activists/leaders of all stripes, to advance the year-long movement that seeks to impact the lives of Houston-area residents in profoundly positive ways for years to come.

The History of African Americans in Houston is aimed at telling the story of the accomplishments of African Americans in Houston. The URRC's community and economic development plan includes work with The Thurgood Marshall School of Law and a local entrepreneur to establish the TSU Institute for Economic and Entrepreneurial Revitalization (TIEER), a non-profit subsidiary of URRC. The goal of the TIEER program is to enhance wealth building in the African American community through entrepreneurship. URRC is also working with a local community development corporation to provide low income housing in north Houston. URRC plans to publish a series of searchable community resource guides with a focus on the Third ward, Fifth ward, Acres Homes, and Sunnyside. These resource guides will also be available on the URRC web page. Johnson assist students' campus wide to participate in all research and writing projects.
