This database will electronically showcase the prolific scholarship of our faculty. Students, faculty, and staff will be able to view faculty scholarship instantaneously with a password through the Thurgood Marshall School of Law Library webpage.

Major Milestone... Librarian Publishes Twice!.. By Danny Norris, Faculty Research Librarian

During the spring semester of 2010 I had the honor of being published twice, once as a single author and once as a co-author. My first work, entitled Houston Gentrification: Options for Current Residents of Third Ward can be found at page 239 of the 35th volume of the Thurgood Marshall Law Review. This article discusses the redevelopment due to the renewed interest in the Houston Third Ward area and what options are available to the current residents who are affected by the sudden increase in the property taxes.

My second work is one which I co -authored with Professor Walter Champion. The article is entitled *Why Not Row to the Bahamas Instead* of Miami: The Conundrum That Awaits Cuban Elite Baseball Players Who Seek Asylum and the Economic Nirvana of Free Agency and can be found at page 219 of the 9th volume of the Virginia Sports and Entertainment Law Journal. This article discusses how the current foreign policy of the United States, as a result of a troubled past with Cuba, actually favors Cuban baseball players to seek asylum in another country so they can be recruited as free agents, as opposed to being drafted by one team, and sign much more lucrative contracts.



FDsys is a one-stop source for digitally signed federal resources. All materials (executive, legislative and judicial) available through the system are authenticated through digital signature.
