# FINDING & DRAFTING USING FORMS & FORMBOOKS

#### Introduction

Drafting documents is an integral part of your daily work in the practice of law. All lawyers draft documents. Civil litigators draft demand letters, letters of representation, original petitions, complaints, interrogatories, jury instructions, settlement agreements, appellate briefs, etc. Criminal lawyers draft plea agreements, writs of habeas corpus, appellate briefs, etc. Transactional attorneys draft contracts, wills, sale of goods, deeds, letters of credit, leases, promissory notes, articles of incorporation, etc. Even more than doing research, you will find that legal drafting is the most heavily used component of practicing law.

Although every document you create will be unique to that client, you do not have to reinvent the wheel. This guide is intended to provide you with an overview of some of the most useful resources for attorneys in drafting legal documents.

Forms are available in various formats. **Commercially published formbooks** provide general drafting information as well as forms specific to subject, jurisdiction, and document-type. **Court-prepared forms** are standardized forms provided by courts for frequently used pleadings or other court procedures. Many firms have **in-house databanks** in which legal documents prepared by attorneys have been archived as forms. Finally, **your own forms file** can be a good source of information. Many formbooks are available in paper and electronic formats.

#### **Formbooks**

Formbooks are considered secondary sources that contain sample legal forms, couched in standard, court-tested language. Forms usually appear in several alternatives, *e.g.*, a long, detailed form or a short form. Usually optional clauses are included that can be added to the basic form when appropriate.

Formbooks are typically multi-volume, looseleaf sets, arranged alphabetically by topic. Forms are accessed by using the index, usually a separate volume that directs the user to appropriate topics and sections. Many formbooks also have comments related to a topic.

#### **Loose-leaf Services**

In practice, attorneys use sets of ring binders that report the law on a particular subject. These sources are called looseleaf services. The material is placed in binders so it can quickly be updated. To learn more about looseleaf services, make an appointment with a law librarian to go over the organization and use of these <u>invaluable</u> publications. Please note most formbooks are looseleaf services.

One author describes looseleaf services as:

"Looseleaf services are like vacuum cleaners pulling together everything on a subject. Unlike vacuum cleaners, when you open a looseleaf service, everything is in order and easy to find. The only loose thing about them occurs when you drop the binder." Marie Wallace, <u>Practice Pointer: Looseleaf Services</u>, 1 no. 2 Perspectives: Teaching Legal Res. & Writing 63 (January, 1993).

**CAUTION:** Formbooks are very useful sources for legal documents. Remember, they were not drafted with your unique legal situation in mind. Many attorneys consciously or unconsciously use 'model' examples as replacements for thinking. Formbooks cannot be used as a short cut to avoid thinking. Check and double-check that the form complies with the requirements and practices of your jurisdiction and your institution. **YOU MUST REVIEW THE LAW.**




