ALTERNATIVELY, IF YOU HAVE COMPLETED APPELLATE LITIGATION IN THE FALL SEMESTER AND RECEIVED ASSOCIATE DEAN LEWIS'S APPROVAL, YOU MAY ENROLL IN A WRITING SEMINAR IN THE SPRING SEMESTER OF YOUR 2ND YEAR, WHICH WILL GIVE YOU A TOTAL OF 29 OR 30 CREDIT HOURS FOR YOUR 2ND YEAR DEPENDING ON THE NUMBER OF CREDIT HOURS FOR YOUR SELECTED WRITING SEMINAR.
