FN 1	Required second year course that must be taken this fall semester 2026.
FN 2	For class of 2028 only.
FN 3	This is a required course that may be taken by the class of 2028 during any semester of their second year or any semester in their third year.
FN 4	Requires 3rd-year status to take course and requires professor signed approval to drop course after August 19, 2026.
FN 5	For 3L students only.
FN 6	Class of 2027 Only: This course is required to be taken any time during 3L year for students with GPA below 3.0 at the end of spring semester of their first year of Law School.
FN 7	Registration requires the completion of an application, interview, and approval by the professor teaching the course
FN 8	To apply, please contact Sarah R. Guidry, Executive Director, Earl Carl Institute at sarah.guidry@tmslaw.tsu.edu; 713-313-1321, for questions and approval process. Once your application is approved by Director Guidry, she will notify the Registrar who will then issue a registration permit to complete your course registration.
FN 9	This course must be taken this fall semester by students who opted out of taking it during their second year.
FN 10	A minimum GPA of 2.6 is required to compete on the competition teams.
FN 11	Independent research I (Law 802) Sec. 1 does not meet weekly as a class. Instead, students work independently with their chosen supervising professor. To register, students must properly complete an online application for Independent Research, secure the signature of supervising professor, submit it via the registrar to the Associate Dean of Academic Affairs for approval.
FN 12	Independent research I (Law 802) Sec. 2 thru 4 meets weekly as a class. Registration is open to all eligible students. Application for independent research paper must be completed with your
FN 13	Independent Research II (803) registration requirements are the same as for Independent Research I Law 802 Sec. 1, except that Independent Research I is a prerequisite for taking Independent Research II.
FN 14	This course meets the writing requirement
FN 15	Minimum GPA of 3.0 required for Federal Courts. Minimum GPA of 2.5 required for State Courts
FN 16	Trial practice is a required component of the related 4 credit course.
FN 17	This is course is graded on the basis of "Satisfactory" or "Unsatisfactory"
FN 18	No student may earn more than 4 credit hours, in total, of special activities during his/her entire period of enrollment at the law school.
FN 19	To register for this course, student must be a 3rd-year student and this fall semester of registration must be the student's third semester of participation in law review. Registration subject to approval from Professor Bennett or successor.
FN 20	Law review senior editors only.
FN 21	Law review editorial board only.
FN 22	All other journals and publications.
FN 23	There are no competitions in this class.
