- FN 4 - Meets the writing requirement. Students must meet the upper-level writing requirement by the end of their third year.
- FN 5 - For 3L students only
- FN 6 - Limited registration course offering. A student may not drop a seminar or clinic after January 15, 2025 unless approval is obtained from Associate Dean Aitsebaomo for seminars or Director Lydia Johnson for clinics.
- FN 7 - Writing sample and resume required. The Criminal Externship requires a clean record.
- FN 8 - Minimum GPA requirement is 2.50 for state court and 3.0 for federal court.
- FN 9A - Independent Research (Sec. 1) is a class that meets once a week with Professor Butler. Registration is open to all students. However, an independent research application must be completed with Professor Butler no later than January 21, 2025 to remain in the class.
- FN B - Independent Research I (Sec. 2) and Independent Research II (Sec. 1) does not meet weekly. Rather, you will be working under the supervision of the professor of your choosing. To register, you must complete the online Independent Research application, secure the signature of the professor supervising your research, and submit your application to the Associate Dean for Academic Affairs at [gabriel.aitsebaomo@tmslaw.tsu.edu](mailto:gabriel.aitsebaomo@tmslaw.tsu.edu) for approval.
- FN 10 - Same requirements and registration process as Independent Research I. However, Independent Research I is a prerequisite for this course.
- FN 11 - Registration requires a completed application, interview, and approval by the respective clinical professor teaching the course.
- FN 12 - All courses listed under 3rd Year Experiential Learning Courses and all 3rd Year Clinics have TWO MANDATORY components: the 4-hour practical and the 2-hour classroom components. BOTH components are required for registration. Please contact Professor Brandon Draper at [brandon.draper@tmslaw.tsu.edu](mailto:brandon.draper@tmslaw.tsu.edu).
- FN 13 - Trial Simulation is a 2-component course. ALL students are REQUIRED to register for one Practicum Session (Section 1-13), AND one Lecture Session (Section 1-2). The registration is not complete without BOTH COMPONENTS.
- FN 14 - Registration only.
- FN 15 - Appellate Litigation is a prerequisite for a seminar course and Independent Research. If you are a 2L student, you may enroll in a seminar in the spring semester of your second year, provided you have successfully completed Appellate Litigation and have registered for all other required second year course by this spring semester.
- FN 16 - Successful criminal background check applies. For federal court or federal government positions, a criminal background check must be completed.
- FN 17 - No student may earn more than 2 credit hours per special activity, or more than 4 credit hours of special activities credit during his/her entire period of enrollment in the law school.
- FN 18 - Commerical Law is a required course. It may be taken at any time in the second year or in the fall semester of the third year.
- FN 19 - Business Associations or Securities Regulations is a prerequisite for this course.
- FN 20 - If you elect to register for Commercial Law in the fall semester of your third year and you have registered for all required second year courses by this spring semester, you may register for one of these elective or experiential learning courses, provided you do not exceed the maximum number of credit hours per semester (16 credit hours).
- FN 21 - Minimum GPA of 2.6 is required to compete on competitive teams.
- FN 22 - These bar courses cannot be dropped after the third day of class unless approval is obtained from Assistant Dean Ronda Harrison.
- FN 23 - To register for this course you must be a third-year student and must have participated in law review for at least three (3) semesters.
- FN 24 - All courses listed under 3rd Year Experiential Learning Courses require: application via CORE elements; resume upload; orientation via CORE Elements; and approval by Externship Director Brandon Draper.
