FN 11	Independent Research II (803) registration requirements are the same as for Independent Research I Law 802 Sec. 1, except that Independent Research I is a prerequisite for taking Independent Research II.
FN 12	This course meets the writing requirement.
FN 13	Minimum GPA of 3.0 required for Federal Courts. Minimum GPA of 2.5 required for State Courts.
FN 14	Trial practice is a required component of the related 4 credit course (2-credit course in the case of students taking Innocence Clinic).
FN 15	This course is graded on the basis of "Satisfactory" or "Unsatisfactory" letter grade.
FN 16	No student may earn more than 4 credit hours, in total, of special activities during his/her entire period of enrollment at the law school.
