IF YOU SELECT 15 HOURS, YOU MUST ENROLL IN 16 IN YOUR SPRING SEMESTER AND VICE VERSA. IF YOU OPT TO DELAY COMMERCIAL LAW UNTIL YOUR THIRD YEAR, YOU MUST ENROLL IN A TOTAL OF 27 MINIMUM CREDIT HOURS FOR YOUR ENTIRE SECOND YEAR. IF NEEDED, YOU CAN CHOOSE TO TAKE AN ELECTIVE IN THE SPRING SEMESTER ONLY, PROVIDED YOU HAVE ENROLLED IN ALL REQUIRED SECOND YEAR COURSES AND RECEIVED ASSOCIATE DEAN LEWIS'S APPROVAL. ALTERNATIVELY, IF YOU HAVE COMPLETED APPELLATE LITIGATION IN THE FALL SEMESTER AND RECEIVED ASSOCIATE DEAN LEWIS'S APPROVAL, YOU MAY ENROLL IN A WRITING SEMINAR IN THE SPRING SEMESTER OF YOUR 2ND YEAR, WHICH WILL GIVE YOU A TOTAL OF 29 OR 30 CREDIT HOURS FOR YOUR 2ND YEAR DEPENDING ON THE NUMBER OF CREDIT HOURS FOR YOUR SELECTED WRITING SEMINAR.
