Diversity in the Profession Committee History

The Diversity in the Profession Committee is one of twenty-seven committees of the State Bar of Texas. In 1989, then State Bar President Darrell Jordan of Dallas created the Committee, formerly known as the Opportunities for Minorities in the Profession Committee. Its purpose was to increase diversity in the profession, enhance opportunities for diverse individuals in the profession, and increase involvement by diverse attorneys in the bar. Just one year after its inception, the State Bar institutionalized the Committee as a standing committee, and its members successfully worked with the State Bar Board of Directors to initiate an ethnicity survey of bar membership, create a permanent staff position dedicated exclusively to minority affairs, and approve support for diversity in State Bar grievance committees. The Committee later adopted its current name, the Diversity in the Profession Committee, to reflect the changing demographics of the state of Texas. Not lost, though, was the Committee's continual focus on promoting and pursuing new prospects and opportunities for all diverse attorneys, including women.

Diversity in the Profession Committee Composition

The Diversity in the Profession Committee is composed of twenty-five accomplished attorneys appointed by the President-Elect of the State Bar of Texas. Committee members serve a three-year term on a volunteer basis.

Scholarship Objectives

The Diversity in the Profession Committee aims to strengthen and diversify the pipeline of individuals entering the legal profession and encourage involvement in the State Bar of Texas by familiarizing students with State Bar activities. By helping defray the financial burden of preparing for the Texas Bar Exam, this scholarship facilitates the transition into the legal profession for law students from backgrounds traditionally under-represented in the profession.

Eligibility and Scholarship Criteria

Third-year law school students, graduates within the past 12 months of an ABA-accredited law school, or those pursuing an LLM, and who are preparing for the 2025 July Texas Bar Exam are eligible for this scholarship. Selection criteria include but are not limited to academic achievement, financial need, involvement in community/extracurricular activities including student organizations and affinity groups, and leadership experience.

Scholarship Information

Historically, the scholarships have been awarded either in the form of cash awards (when available) and/or credit toward bar prep course costs (for BarBri's Guided Pass Course, Themis' Full Bar Review Course, and Kaplan's Bar Review Course). Some of the bar prep company-specific awards under this scholarship are discounts off the full list price of the bar prep courses or monetary credits toward a bar prep course. The Diversity in the Profession Committee is not responsible for determining your arrangement with a bar prep course company nor will it have the flexibility to reallocate awards once they are made. To the extent you have already paid for a bar prep course or have received a discount on a course, the Committee cannot warrant how or whether the company-specific awards will be applied to your account. If a firm or other entity pays for your bar prep costs or a portion of your costs after you've applied for this scholarship, please let us know immediately so we can allocate those funds to other applicant(s).
