At [Enbridge](#), the goal is to be the first-choice energy delivery company in North America and beyond—for customers, communities, investors, regulators and policymakers, and employees. ABOUT THE SCHOLARSHIP

To support law students at the Texas Southern University Thurgood Marshall School of Law (TMSL), Enbridge is awarding five scholarships valued at \$1,200 each. The scholarship awards will be applied to the student's TSU account. Students can compete to win scholarships for the Fall and Spring semesters. Three scholarships were awarded for Fall 2025 to a 1L, 2L, and 3L student. Two scholarships will be awarded for Spring 2026 to two students.

ELIGIBILITY CRITERIA

To be eligible to receive an Enbridge Scholarship for Spring 2026, an applicant must meet all the following requirements:

1. Was not previously awarded the Enbridge scholarship for Fall 2025.
2. Be a current full-time student at TMSL for Spring 2026.
3. Must have achieved a minimum cumulative grade point average of 2.5 during the Fall semester.

SUBMISSION GUIDELINES FOR SPRING 2026 APPLICANTS

The Enbridge Scholarship application will be completed in Symplicity. Students should be prepared to submit the following:

1. In 500 words or less (minimum 350 words), respond to the following essay prompt:
Describe a personal experience, challenge, or observation that sparked your interest in the law. Explain how this experience has shaped your perspective on justice, ethics, or advocacy. How has this influenced your aspirations for a legal career?
 - a. Students should use the following nomenclature for their file:

2. Submit a copy of your 1-page legal resume.
 - a. Students should use the following nomenclature to name their file:
LastnameFirstname_resume_EnbridgeSpr26
3. Submit a copy of your most recent unofficial transcript.
 - a. Students should use the following nomenclature to name their file:
LastnameFirstname_unofficialtranscript_EnbridgeSpr26

To access the application, log into your Symplicity account. Click Jobs > Search. Under the “Position Type” drop down, click the box next to “Scholarships” and then click the “Apply” button. The search results should include the Enbridge Scholarship.

Scholarship recipients can only receive the award one time during the 2025-2026 academic year.
