- (b.) A letter of reference (1) from the respective law school (Professor, Dean, Head, or other Executive Admin).
- (c.) A sealed official transcript bearing the college or university seal indicating a cumulative grade point average of 3.00 or

above. Please provide conversion of your grades to the" 4.0 grading scale" if your college or university does not use this scale. (d.) Copy of law school acceptance letter required for 1L applicants.

- (e.) Applicant must be available for a virtual interview Saturday, June 24, 2023, if selected as a finalist.
- (f.) A Personal Profile (Biography or Resume').
