

FREQUENTLY ASKED QUESTIONS

GENERAL PUBLIC

What are the Library's Hours of Operation?

The Law Library's current operating hours schedule is:

Monday – Thursday (7:30 AM – 10:00 PM) Friday (7:30 AM – 6:00 PM) Saturday (9:00 AM – 9:00 PM) Sunday (12:00 PM – 9:00 PM)

Library hours are subject to change during examination periods, semester breaks, and holidays. Changes to library hours are posted on the marquee at the front entrance of the library. To verify the library's hours, contact the circulation desk at 713-313-7125 or our <u>Facebook</u> page.

Can the public use the Law Library?

Yes. The Law Library's collection is available to the public for in-library research during posted library hours. Public patrons must have a current TexShare card to borrow circulating materials. Public patrons must present a picture ID to borrow Reserve materials and their ID will be returned when the item is returned to the Circulation Desk. Professional research assistance is available to all patrons during our posted Reference Hours. Computer use is limited to TSU faculty, staff, and students only.

Can the law library staff answer my legal questions?

Reference Services are available to assist with questions about the collection, to help find specific legal materials, or to set up a research strategy. The reference librarians <u>cannot</u> give legal advice or interpretations of the law; please consult an attorney who is engaged in the practice of law for such assistance. The Law School has a Legal Clinic and several institutes such as the Earl Carl Institute that provides legal assistance to the community. Can I get legal assistance from the law students?

No. Law students are not licensed attorneys and therefore cannot provide legal assistance in any matter. The Law School has a Legal Clinic and several institutes such as the Earl Carl Institute that provides legal assistance to the community.

Does the Law Library Have Public Meeting Rooms?

No. Any conference rooms that the Law Library have are reserved for use by TMSL faculty, staff, and students.

Can I obtain legal forms/ Self Service documents (Family Law, Criminal Law, etc.) from the Law Library?

Yes. Professional reference assistance is available for locating legal forms. Most of our legal forms are in our Reserve collection and online resources. The Reserve Collection is located behind the Circulation Desk. These items include materials such as Dorsaneo's Texas Litigation Guide, Texas Transaction Guide, and the State Bar of Texas forms. Reserve materials may be checked out for use in the Law Library for a period of two hours by a TSU patron or a public patron presenting a valid identification card. Please be advised that library staff can help locate these forms but cannot assist patrons with completing and filing them. There is a scanner where patrons can scan the documents that they need free of charge.

Other great resources for locating forms are the <u>Harris County Law Library</u> and <u>Texas Law Help</u>. The Harris County Robert W. Hainsworth Law Library provides you with links to assist you in locating forms. These links take you to other organizations' websites. The Harris County Law Library is open Monday-Friday, 8 a.m. to 5 p.m., located on 1019 Congress, 1st floor, Houston, Texas 77002, and its phone number is 713-755-5183. The <u>Legal Clinic</u> at TMSL is both an educational and legal service provider. The legal service component focuses on providing legal representation to people who cannot afford to hire a lawyer. What old exams are available at the Library?

A <u>limited</u> number of old exams are available in the law library. Old exams are made available for student use at the Circulation Desk and are treated as Reserve materials.

How to Access a Physical Item from the Library?

Physical items can be checked out from the library's Circulation Desk. Check the <u>catalog</u> for an item's availability. The Circulation Desk is staffed during all hours that the library is open. Desk attendants are available here to answer general questions and circulate library materials. Circulating library materials are loaned for a four-week period. Contact the Circulation Desk at (713) 313-7125 for assistance.

Will Library Hours Be Extended During Midterms & Finals?

Library hours are usually extended 2 hours past the normal closing time during the examination periods. Extended Hours notices will be posted throughout the library during that timeframe. To verify the library's hours, contact the circulation desk at 713-313-7125 or our <u>Facebook</u> page.

Are there Accommodations for Bar Study?

Study Room Policies - Can Study Rooms Be Reserved Online?

There are 16 individual and 1 group study room located on the basement floor level. These are available on a first-come, first serve basis each day for law students ONLY. <u>All study rooms must be reserved at the Circulation Desk.</u> You cannot reserve a room ahead of time, no more than 15 minutes before your desired time of use. Rooms can be reserved for 2 hours at a time, with a maximum of 4 hours per day if available.

Does Westlaw & Lexis Nexis allow us to use form building software?

• Lexis

There are Sample Forms within the content of Lexis+. Lexis also has a product *Practical Guidance* that is a transactional tool that features practice notes, forms, checklists, and drafting tools. For assistance with research or drafting forms, call 1-800-45LEXIS.

• Westlaw

There is *Drafting Assistant* that allows you to upload Word documents and has special tools and features that you can apply to your uploaded document i.e. Citation Check. There is also *Westlaw Form Builder* which is Westlaw's online document assembly tool. You can also customize, build, and save your own forms to *Westlaw Form Builder*. For assistance with research or drafting forms, call 1-800-WESTLAW.

I was never issued a Lexis and/ or Westlaw password. How do I obtain one?

Contact the Circulation Desk or the Systems Librarian for assistance. You will then be directed to the Lexis/ Westlaw Academic Representative(s) for confirmation that you should receive a password.

How do I access CALI?
