Hello to all of our colleagues and friends:

We have just completed our first year and a half of existence, and if the last 18 months are any indication, the future for the Institute for International and Immigration Law looks bright. We wanted to take this opportunity to inform you of our activities and accomplishments to date.

In the area of academics, the Institute awarded 8 certificates to students graduating from Thurgood Marshall School of Law who had completed our rigorous international and immigration certification requirements. Students are required to complete 11 hours of course work with a 3.0 average for international and/or immigration courses, and a 2.5 grade point average overall. We anticipate qualifying several students this year for the certification as well.

Our certification program allows students receiving certification to market themselves in the job search as having specialized concentrations in either immigration law or international law, or both. Though our program is new, several students from the first class have indicated that their job prospects were positively affected by the certification. As our program grows we anticipate that the value of a certificate in international and immigration law from our program will grow as well.

One of the reasons our certification program has and will continue being a success is our Turbo Course program of intersession classes. Each year, the Law School offers a variety of courses in international and immigration law over a two and a half week period between the end of the spring semester testing period and the beginning of the summer session. The Turbo Courses allow students course selection flexibility. The program also allows the Law School to offer a variety of specialty courses in the two areas, and to invite scholars from around the nation to the campus to teach our students.

This year, our Turbo Course faculty will include Professors Placido Gomez (International Evidence) and Lee Teran of St. Mary's University Law School (Immigration), and Professor Sherrie Russell Brown of the University of Florida Levin School of Law (War Crime Tribunals—International Criminal Law). We selected several outstanding members from the international, immigration, and alumni communities to serve on our Board of Advisors. This board will provide valuable assistance and advice in a variety of areas and projects undertaken by the Institute. Mr. James Okorafor, a graduate of Thurgood Marshall School of Law, kindly agreed to serve as board chair at a dinner meeting held last October to introduce our board and Institute faculty to each other. One of the principal purposes of the Institute was to provide a forum for the discussion, and perhaps, solution to problems in international and immigration law. Last year, we held one of the first conferences in the world on the African Union, the political and economic integration project that went into effect in July of 2002.

Our conference was held on the weekend of February 22-23 of 2003, at Texas Southern University and at the Hyatt Regency Houston. Scholars from the United States, Canada, and South Africa took part. The guest speaker was Thandabantu Nhlapo, the Deputy Chief of Mission, Embassy of the Republic of South Africa to the United States. Ambassador Nhlapo's remarks and those of the panelists sitting on five separate panels dealt with a variety of issues relating to African development and continental cooperation. Papers from the conference are being published in the next edition of the Iowa Journal of Transnational Law and Contemporary Problems, one of the nation's more prestigious international law journals. Our next project includes the production of a monograph series of occasional papers in the areas of immigration and international law and summer study abroad programs for our students. This includes one program in the works to send our students to The Hague, Netherlands, to study international tribunals with the guidance of our former faculty member, current board member, and former President of the International Criminal Tribunal for the Former Yugoslavia, Judge Gabrielle McDonald. Judge McDonald, who is currently serving on the Iran-US Claims Tribunal, has graciously agreed to help design a summer intern/study program for our international law students. We expect this program to be up and running by summer of 2005.

Our program is new and we have accomplished a lot over the past year and a half. We are excited about the potential for development in the area of immigration law and international law via the Institute, but most importantly, we are focused on the mission of the Institute that includes the following goals:

- Prepare qualified and confident students trained for positions with law firms practicing international or immigration law; U.S. government agencies, foreign governments, and private organizations and foundations working to advance social and economic justice.
- Prepare well-educated students with an understanding of the complex issues related to international ad immigration law.
- Provide a scholarly atmosphere for the student of international law and immigration law, and to provide forums for the discussion of problems facing those disciplines.
