

Law Library Study Aids and Supplements

What kinds of the study aids does the library have? This is a question we often hear at the Circulation Desk. Although we do not buy all of the study aids which are available for you to purchase in the bookstore, we do carry some of them in the reserve section and make them available for use while in the Law Library. We also have some older editions in our circulation area which may be checked out from the Law




Library.

One of the most popular study aids we carry are the books in the "Law in a Nutshell" series. These are short works on broad legal topics which you can use when you need a quick overview of the law on a topic. The "Hornbook" series contains more detailed discussions of aspects of the law than the Nutshell books. Both the Nutshells and Hornbooks have been used by many students over the years. Two newer titles in the world of study aids are the "Understanding" books and the "Examples and Explanations" series. The

"Understanding" books are discussions of the law, and are similar to the hornbooks. The "Examples and Explanations" books provide a short discussions of various topics of law, followed by questions and answers. Some students find that this question and answer format is a useful tool when preparing for exams.

These reserve materials can be checked out for 2 hours, for inlibrary use only. The earlier editions of these materials are kept in the



stacks, and may be checked out for 2 week time periods. If you want to check our online catalog for one of these study aids, try doing a keyword search using the series name and the name of the topic you are want to read. For example, you could do a keyword search for the terms nutshell and admiralty.

iPADs

Library Food and Beverage Policy



Beverages are permitted in a pre -approved, non-spill containers. Patrons with drinks in unapproved

containers will be asked to remove such items.

Food will be permitted in the form of individual snack size containers of dry foods like chips, cookies, candy, granola bars, and other relatively non-messy, individually packed snack foods.

Please discard all food containers in the trash cans near the study rooms, basement elevator and at the main library exit.

All library staff members are authorized to enforce this policy.

Food is considered acceptable as long as it meets the following conditions:

If you can buy it in a vending machine and it's not a liquid, frozen or wet.

It is not meant to be eaten with a fork or spoon.

Food from vending machines like the one pictured are generally acceptable in the library.

Drinks and food are NOT allowed in the computer lab and photocopy area.
