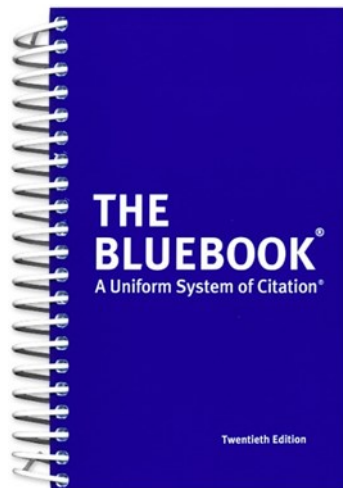

The 20th Edition of the Bluebook has Arrived at TMSL Library

In June, the 20th edition of *The Bluebook: A Uniform System of Citation* was published. The Thurgood Marshall School of Law's Library has copies of the 20th edition that have replaced its 2010 edition on Reserve. Bluebook users with subscription access to the electronic version at LegalBluebook.com can view the new edition online. (Purchasers of the print edition will also receive a code for a 30-day free trial of the online version; or the book can be purchased as a bundle with online access for up to 3 years.) I know you're

wondering so what's the difference? Some key differences are that the new edition adds sources and terms to various tables, clarifies rules regarding quotations within a quotation,

and Rule 18 includes new material, which governs the citation of electronic resources. Although the Bluebook continues prefer print editions for some citations, such as the date of a statutory code volume, the new edition does allow for the use of online newspapers as a substitute for print, and no longer requires pagination. Law librarian Janelle Beitz compiled a list of differences between the 19th and 20th editions on Google Drive. "#WhatHappenedtoSandraBland?" Forum



On Tuesday August 4, 2015, the Earl Carl Institute for Legal & Social Policy, Inc., hosted a forum entitled "#WhatHappenedtoSandraBland?", discussing the controversial "alleged suicide of Sandra Bland while in police custody. Sandra Bland was a young woman who was recently arrested in Prairie View, Texas after being stopped by police while driving. She was

later found dead in a Waller County jail cell. The forum consisted of representatives from the US Congress, the Texas Legislature, the Texas Organization Project, Texas Southern University, the US Department of Justice Community Relations Service, and a member of the review committee for the Bland case.

The purpose of the

forum was to: foster collaborations that would formulate specific policy recommendations, devise mechanisms for highlighting incidents everywhere, establish research priorities for issues needing further development and lastly, to receive public comments on prioritizing strategies and soliciting persons interested in further developing these strate-

gies.

There were more than 300 attendees. Additionally, the forum was broadcast online live via LiveStream. The forum was highly energized and at times the discussion became a bit difficult. The resolve was that there was still much left to do on this matter and that this forum would not be the last on addressing the issue of the police interaction with the community.

Library Food and Beverage Policy

Beverages are permitted in a pre-approved, non-spill containers. Patrons with drinks in unapproved containers will be asked to remove such items.

Food will be permitted in the form of individual snack size containers of dry foods like chips, cookies, candy, granola bars, and other relatively non-messy, individually packed snack foods.

Please discard all food containers in the trash cans near the study rooms, basement elevator and at the main library exit.

All library staff members are authorized to enforce this policy.

Food is considered acceptable as long as it meets the following conditions:

If you can buy it in a vending machine and it's not a liquid, frozen or

wet.

It is not meant to be eaten with a fork or spoon.

Food from vending machines like the one pictured are generally acceptable in the library.

Drinks and food are NOT allowed in the computer lab and photocopy area.
