### TMSL Librarians Present At TLA District 8 Conference

Patrina Epperson, Circulation Librarian and Shante Clark-Davis, Electronic Resources Librarian attended and presented on Using Wikispaces to Share Reference and Circulation Statistics at the Texas Library Association District 8 Conference on Saturday, October 22, 2011. The Conference was held at University of Houston's M.D. Anderson Library. Their presentation focused on how our staff compile and share our library statistics through the use of Wikispaces. Wikispaces is a safe online environment that provides web pages that a group can edit together. It is beneficial because: Wikispaces ensures that library staff collectively stays on the "same page." Wikispaces is used as an internal communication system allowing library staff to communicate statistics, authentic patron questions, and basic communication.

Participants included librarians who are library school students, school and public librarians from around Houston and surrounding areas. Their presentation ensured that various librarians are familiarized with creating, maintain-

ing, and utilizing Wikispaces to collect statistics and communicate effectively with their staff and organizational stakeholders. All participants were grateful for the presentation and stated that they will go back to their campuses or organizations and implement Wikispaces to record their library statistics. We also shared other ways Wikispaces can be utilized to communicate with teachers, administrators, and parents. We even encouraged them to teach their teachers and staff how to utilize Wikispaces for communication or classroom tools.


